AN ORDINANCE ENACTING SECTION 163.28 OF THE MUNROE FALLS CODIFIED ORDINANCES PROVIDING FOR FACILITY RENTAL FEES AND DECLARING AN EMERGENCY.

WHEREAS, the City owns certain facilities which are available for rent within the City of Munroe Falls; and

WHEREAS, the City, through its several Committees and with the assistance of the Administration and City Council, desire to establish certain rental fees for City facilities.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MUNROE FALLS, COUNTY OF SUMMIT, AND STATE OF OHIO, THAT:

Section 1. Council hereby enacts Section 163.28 of the Codified Ordinances of the City of Munroe Falls to read as follows:

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and all deliberations of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

Section 3. This Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, safety and welfare of the City of Munroe Falls, and further to provide adjusted rental rates for City facilities and provided that it receives the affirmative vote of two-thirds of the members elected to Council, it shall take effect immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in force at the earliest period allowable by law.
