**AN ORDINANCE AMENDING SECTIONS 181.07(d)(1) AND (2) OF THE MUNROE FALLS CODIFIED ORDINANCES TO INCREASE THE THRESHOLD FOR THE PAYMENT OF ESTIMATED TAXES, AND DECLARING AN EMERGENCY.**

**WHEREAS**, the City currently has in place income tax legislation; and

**WHEREAS**, said income tax legislation provides for a declaration of estimated tax paid to the municipality; and

**WHEREAS**, the City desires to increase the threshold for the payment of estimated taxes from \$100.00 to \$400.00.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MUNROE FALLS, COUNTY OF SUMMIT AND STATE OF OHIO THAT:**

**Section 1.** Sections 181.07(d) (1) and (2) are hereby amended to delete the numerical value of \$100.00 and replace it with a numerical value of \$400.00.

**Section 2.** It is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.00 of the Ohio Revised Code.

**Section 3.** This Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, safety and welfare of the residents of the City of Munroe Falls and further to provide relief to taxpayers for declaration of estimated taxes within the City and provided that it receives the affirmative vote of two-thirds of the members elected to Council, it shall take effect and be in full force from and immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in full force from and after the earliest period allowed by law.
