AN ORDINANCE ADOPTING THE RECOMMENDATIONS OF THE CHARTER REVIEW COMMISSION TO PLACE ON THE BALLOT A CHARTER AMENDMENT TO ARTICLE 5 SECTION 5.04, ENTITLED "PRESIDENT AND VICE PRESIDENT OF COUNCIL" REGARDING THE POWERS OF THE PRESIDENT OR VICE PRESIDENT WHILE ACTING AS TEMPORARY MAYOR.

WHEREAS, the City of Munroe Falls, through its Charter, provides for periodic review of the Charter by an appointed Charter Review Commission; and

WHEREAS, pursuant to the Charter, a Charter Review Commission was assembled and has provided its recommendations to City Council, in writing, dated June 15, 2012; and

WHEREAS, City Council has considered said recommendations and desires to accept the recommendations for purposes of submitting the proposed amendment to the electors.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MUNROE FALLS, COUNTY OF SUMMIT AND STATE OF OHIO THAT:

Section 1. The following proposed amendment to the Charter of the City of Munroe Falls be brought to the electors at the next General Election, currently scheduled for November 2012.

The Council shall at each Organizational Meeting, by majority vote, elect from its Members a President of Council who shall preside at meetings of Council and a Vice President of Council who shall preside at meetings of Council in the absence of the President of Council. The President and Vice President of Council, neither by virtue of holding such offices nor in performing the duties of Acting Mayor, as provided in Section 4.07 of this Charter, shall be deprived of their powers and rights or be relieved of any of their duties and obligations as Members of Council except during such period as the President or Vice President of Council shall be the Acting Mayor he/she shall cast votes on legislation only when necessary to break a tie vote. Otherwise, while serving in the capacity as Acting Mayor, the President or Vice President of Council shall not otherwise vote on legislation.

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in
