AN ORDINANCE TO PLACE ON THE BALLOT A CHARTER AMENDMENT ENACTING ARTICLE 4 SECTION 4.03(h), REGARDING MAYORAL APPOINTMENTS AND DISMISSALS TO THE PARKS AND RECREATION BOARD, PLANNING AND ZONING COMMISSION, BOARD OF ZONING AND BUILDING APPEALS, AND CHARTER REVIEW COMMISSION.

WHEREAS, the Charter of the City of Munroe Falls empowers City Council to place Charter Amendments on the ballot; and

WHEREAS, pursuant to the Charter, City Council desires to submit to the electors a proposed amendment to the Charter regarding certain Mayoral appointments.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MUNROE FALLS, COUNTY OF SUMMIT AND STATE OF OHIO THAT:

Section 1. The following proposed amendment to the Charter of the City of Munroe Falls be brought to the electors at the next General Election, currently scheduled for November 2012.

The Mayor in exercising his/her appointing authority to appoint or dismiss members to the Parks and Recreation Board under Article XI, Section 11.01, Planning and Zoning Commission, under Article XII, Section 12.01, Board of Zoning and Building Appeals, under Article XIII, Section 13.01, and Charter Review Commission, under Article XVIII, Section 18.01, shall submit the proposed action individually for confirmation by Council.

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.00 of the Ohio Revised Code.
