**AN ORDINANCE AUTHORIZING ALL ACTION NECESSARY TO INCREASE THE OP&F MEMBER CONTRIBUTION RATE AND DECLARING AN EMERGENCY.**

WHEREAS, certain employees of the City of Munroe Falls are eligible to participate in the Ohio Police & Fire Pension Fund ("OP&F"); and

WHEREAS, Council has previously adopted a pick up of the mandatory contributions required under Section 742.31 of the Ohio Revised Code for participating employees who are members of the OP&F; and

WHEREAS, the OP&F has increased the member contribution rates for the years 2013 through 2015; and

WHEREAS, Council wishes to amend it prior legislation to provide for the rate changes.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MUNROE FALLS, COUNTY OF SUMMIT, AND STATE OF OHIO, THAT:

Section 1. Effective July 15, 2013 through July 13, 2014, the member contribution rate will be increased to 10.75%. For the period July 14, 2014 through July 12, 2015, the member contribution rate will be increased to 11.5%. For the period beginning July 13, 2013 and thereafter, the member contribution rate will be increased to 12.25%.

Section 2. Said pick-up contributions shall continue to be withheld from the employees' earnings and reported for federal and state tax purposes as previously reported.

Section 3. It is found and determined that all formal action of this Council concerning or relating to the adoption of this Ordinance was adopted in an open meeting of this Council and all deliberations of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

Section 4. This Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, safety and welfare of the City of Munroe Falls, and further so as to allow for timely change in the member contribution rate that is scheduled to go into effect July 15, 2013, and provided that it receives the affirmative vote of two-thirds of the members elected to Council, it shall take effect immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force at the earliest period allowable by law.
