AN ORDINANCE AMENDING SECTION 163.02 OF THE MUNROE FALLS CODIFIED ORDINANCES TO ESTABLISH FEES ASSOCIATED WITH THE INSTALLATION OF DRIVEWAYS, DRIVEWAY APRONS, AND CURB CUTS, AND DECLARING AN EMERGENCY.

WHEREAS, the City currently requires permits and fees in connection with the installation of driveways, driveway aprons, and curb cuts; and

WHEREAS, the City has determined that certain adjustments need to be made relative to said permits and fees.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MUNROE FALLS, COUNTY OF SUMMIT AND STATE OF OHIO THAT:

Section 1. Section 163.02 is hereby adopted in its entirety to read as follows:

“163.02 Driveway, Driveway Aprons, and Curb Cut Fees.

- (a) Driveways and Driveway Aprons - \$10.00.
(b) Curb Cuts - \$10.00.”

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.00 of the Ohio Revised Code.

Section 3. This Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, safety and welfare of the residents of the City of Munroe Falls and further to immediately amend the fees associated with driveways, driveway aprons, and curb cuts and provided that it receives the affirmative vote of two-thirds of the members elected to Council, it shall take effect and be in full force from and immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in full force from and after the earliest period allowed by law.
