AN ORDINANCE AMENDING SECTION 163.09(i)(5) OF THE MUNROE FALLS CODIFIED ORDINANCES TO ELIMINATE HOMEOWNER DEPOSITS FOR WATER SERVICE, AND DECLARING AN EMERGENCY.

WHEREAS, the City currently requires a deposit from homeowners for water service within the City; and

WHEREAS, the City has determined that homeowner deposits are no longer necessary; and

WHEREAS, the City wishes to retain water service deposits for non-owner occupied housing.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MUNROE FALLS, COUNTY OF SUMMIT AND STATE OF OHIO THAT:

Section 1. Section 163.09(i)(5) is amended in its entirety to read as follows:

“(5) Schedule 5: Deposits. Any individual subscriber, except the owner of the property, shall be required to deposit \$150.00 with the Munroe Falls Water Department when establishing new water service.”

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.00 of the Ohio Revised Code.

Section 3. This Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, safety and welfare of the residents of the City of Munroe Falls and further to immediately eliminate water deposits for owner occupied housing and provided that it receives the affirmative vote of two-thirds of the members elected to Council, it shall take effect and be in full force from and immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in full force from and after the earliest period allowed by law.
