**AN ORDINANCE AMENDING SECTION 711.02 OF THE MUNROE FALLS CODIFIED ORDINANCES ENTITLED "ALARM USERS PERMIT" TO ELIMINATE THE REGISTRATION FEE AND RENEWAL FEES FOR RESIDENTIAL ALARM SYSTEMS, AND DECLARING AN EMERGENCY.**

**WHEREAS**, the City of Munroe Falls currently requires a registration fee and renewal fees for residential alarm systems; and

**WHEREAS**, the City desires to eliminate the registration fee and renewal fees for residential alarms.

**NOW, THEREFORE, BE IT ORDAINED** BY THE COUNCIL OF THE CITY OF MUNROE FALLS, COUNTY OF SUMMIT AND STATE OF OHIO THAT:

Section 1. Section 711.02(b) is amended to read as follows:

"(b) Application for an alarm user's permit shall include the following information:

... "

Section 711.02(c) is amended to read as follows:

"(c) Application for the renewal of an alarm user's permit shall be made very year within thirty days immediately preceding the July 1 of every year."

Section 711.02(f) is amended to read as follows:

"(f) A twenty-five dollar (\$25.00) application charge will be charged to an alarm user who is more than thirty days delinquent in renewing a permit."

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.00 of the Ohio Revised Code.

Section 3. This Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, safety and welfare of the residents of the City of Munroe Falls and further to provide for the immediate cessation of alarm application and renewal fees and provided that it receives the affirmative vote of two-thirds of the members elected to Council, it shall take effect and be in full force from and

immediately upon its passage and approval by the Mayor; otherwise, it shall take effect and be in full force from and after the earliest period allowed by law.
