AN ORDINANCE AMENDING SECTION 161.04 OF THE MUNROE FALLS CODIFIED ORDINANCES.

WHEREAS, the City has adopted a P.E.R.S. PICK-UP Ordinance; and

WHEREAS, said Ordinance requires amendment to comply with current P.E.R.S. requirements.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MUNROE FALLS, COUNTY OF SUMMIT AND STATE OF OHIO THAT:

Section 1. Section 161.04, entitled "P.E.R.S. Pick-Up", is amended to read as follows:

"161.04 P.E.R.S. PICK-UP.

- (a) Effective as of 12:01 a.m. of April 30, 1984, and subject to the provisions of subsection (c) hereof, the full amount of the statutorily required contributions to Public Employees Retirement Systems of Ohio shall be withheld from the gross pay of each person and shall be "picked up" (assumed and paid to the Public Employees Retirement Systems of Ohio) by the Municipality.
- (1) This "pick-up" by the Municipality commencing as of April 30, 1984, is and shall be designated as, public employee contributions and shall be in lieu of contributions to the Public Employees Retirement Systems of Ohio by each person. No person subject to this "pick-up" shall have the option of choosing to receive the statutorily required contribution to the Public Employees Retirement Systems of Ohio directly instead of having it "picked up" by the Municipality or of being excluded from the "pick-up".
- (2) The Municipality shall, in reporting and making remittance to the Public Employees Retirement Systems of Ohio, report that the public employees contribution for each person subject to this "pick-up" has been made as provided by statute.
- (b) The "pick-up" by the Municipality as provided by this section shall apply to all full time and part time employees of the Municipality who are contributing members of the Public Employees Retirement Systems.
- (c) The gross wage or salary of any person subject to the "pick-up" provided by this section shall not change as a result of this "pick-up"."
