**AN ORDINANCE SEPARATING THE POSITIONS OF DIRECTOR OF FINANCE AND CLERK OF COUNCIL, AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Charter of the City of Munroe Falls, in Section 5.12 entitled "Clerk of Council" authorizes Council to separate the positions of Director of Finance and Clerk of Council; and

**WHEREAS**, pursuant to said Charter, the Council desires to separate the positions of Director of Finance and Clerk of Council.


**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MUNROE FALLS, COUNTY OF SUMMIT AND STATE OF OHIO THAT:**


**Section 1.** That pursuant to the Charter of the City of Munroe Falls, to wit: Section 5.12, Council hereby enacts this Ordinance separating the positions of Director of Finance and Clerk of Council.


**Section 2.** Pursuant to said Charter, Council retains the authority to appoint Clerk of Council to serve at the pleasure of Council.

**Section 3.** It is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.00 of the Ohio Revised Code.

**Section 4.** This Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, safety and welfare of the residents of the City of Munroe Falls and further to allow for the immediate appointment of a "Clerk of Council" to begin employment January 4, 2016 and provided that it receives the affirmative vote of two-thirds of the members elected to Council, it shall take effect and be in full force from and immediately upon its passage.
